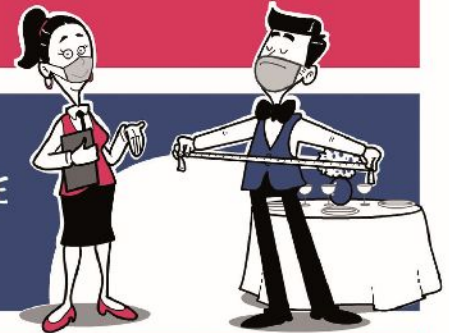

STAY AT HOME OR LEAVE THE WORKPLACE IMMEDIATELY IF YOU HAVE A FEVER (TEMPERATURE HIGHER THAN 37,5°) OR OTHER INFLUENZA SYMPTOMS

STAFF MEMBERS MUST CORRECTLY PUT ON AND WEAR PERSONAL PROTECTIVE EQUIPMENT (PPE)

ABIDE BY THE SOCIAL DISTANCING RULES. WHERE POSSIBLE, KEEP AT LEAST ONE METRE AWAY FROM OTHER PEOPLE

TAKE GREAT CARE OVER PERSONAL HYGIENE AND MAKE SURE PARTICULARLY THAT YOUR HANDS ARE CLEAN AT ALL TIMES. WASH YOUR HANDS WITH SOAP AND WATER OR SANITIZING GEL FOR AT LEAST 20 SECONDS EVERY HOUR AND ALWAYS AFTER COMING INTO CONTACT WITH OBJECTS USED BY CUSTOMERS

DO NOT GATHER TOGETHER WITH COLLEAGUES IN SHARED SPACES (AND IN PARTICULAR IN HANGING ROOMS)

WHEN GOODS ARE BEING LOADED OR UNLOADED, KEEP AT LEAST ONE METRE AWAY FROM THE TRANSPORTER, WHO MUST WEAR MASK AND GLOVES WHEN NOT IN THE VEHICLE

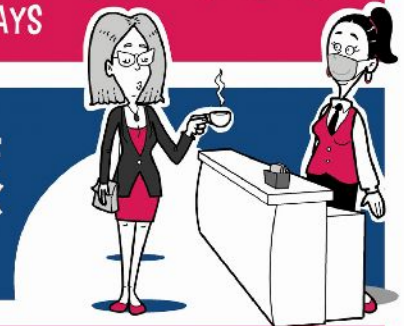

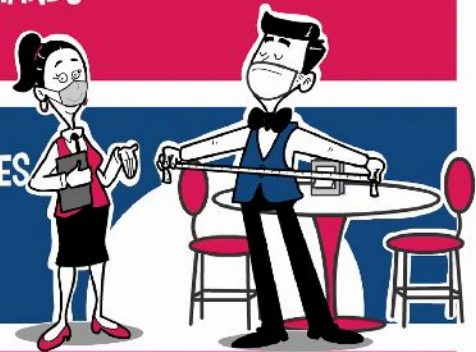
